PAYMENT ARRANGEMENTS:

If you've fallen behind on your bills, just give us a call to see if you're eligible for a payment arrangement.

TIME OF USE RATE:

This optional rate gives you the control to save by choosing when you use electricity.

BUDGET BILLING:

With budget billing, your electric bill won't surprise you each month, no matter what Mother Nature throws our way. We figure out your payment by looking at your last year's energy use at home. To get started with budget billing, we'll need a year's worth of billing history. Members with past due accounts do not qualify.

WINTER PROTECTION PROGRAM:

This program is designed to support low-income members and seniors during the heating season (November 1–March 31). While you still have to pay your bill, the program gives you extra time and protects eligible members from shutoff during the winter months.

To qualify members must fit one of the following categories:

- Low-income: Members must have used up all state and federally funded utility assistance options.

 Participating members are required to pay at least 7% of their estimated annual bill during the heating season.
- Senior Citizens: Members over the age of 65 won't have to worry about being disconnected during the winter months. But it's a good idea to chip away at that bill when you can, so it doesn't pile up. Members are responsible for making the cooperative aware of age, proof may be required.

MEDICAL EMERGENCY PROTECTION:

The cooperative can hold off on cutting off your service for 21 days, with a note from your doctor. The note should say what medical condition you have, any life-support equipment you're using, who's getting the care, and where you need the electricity. If you need more time, just get another note from the doctor. But keep in mind, you can only do this three times a year.

MILITARY PROTECTION:

If you're full-time active duty and find yourself shipped overseas due to a war or some kind of conflict, or even if you're stationed stateside for a national or state emergency; we won't cut off your service for 90 days, after you notify us. We thank you for your service.
