



BOARD CANDIDATE CAMPAIGN FINANCIAL DISCLOSURE FORM

The purpose of the Campaign Financial Disclosure Form is to report to the Cooperative the name and address of any individual or entity who a) provides any financial contribution, payment, or in-kind service to or for the benefit of the Board candidate or b) purchases or procures any known advertising for the benefit of the Board candidate. While a board candidate is required to identify all contributors, the specific dollar amount of any contribution may be disclosed voluntarily.

This form is due to the Cooperative’s Executive Administrative Assistant ON THE EXACT DATE as follows:

- **April 16, 2026:** fifteen (15) days prior to the commencement of the election (the time the members are first allowed to vote electronically or otherwise)
- **May 15, 2026:** fifteen (15) days after the election commences, and
- **June 10, 2026:** the day before the election closes


Any Board candidate campaign finance report received by the Cooperative, or lack thereof, along with the Board candidate’s biography, shall be made available to the membership via the Cooperative’s online election resources, including but not limited to, the Cooperative’s website.
